## Privacy Policy

This following sets forth the Privacy Policy for the Central Australia Academic Health Science Network website, [www.caahsn.org.au](http://www.caahsn.org.au).

Central Australia Academic Health Science Network is committed to providing you with the best possible customer service experience. Central Australia Academic Health Science Network is bound by *Privacy Amendment (Private Sector) Act 2000*, which amends the Commonwealth *Privacy Act 1988* ('the Privacy Act') to establish minimum privacy standards for the Australian private sector, including for all private sector organisations that both provide health services and hold health information. The legislation applies from 21 December 2001. The Privacy Act creates a single, nationally consistent framework for protecting privacy and as Commonwealth legislation it prevails over State or Territory privacy legislation, to the extent that these laws are inconsistent.

### Collection of your personal information

There are aspects of the site which can be viewed without providing personal information, however, you may be required in the future to submit personally identifiable information. This may include but not limited to a unique username and password, or provide sensitive information in the recovery of your lost password.

### Sharing of your personal information

Central Australia Academic Health Science Network does not sell, rent or trade personal information about you to or with third parties. In some circumstances, however, personal information may be disclosed outside Central Australia Academic Health Science Network. For example, we may disclose it if:

- we are required or permitted by law;
- disclosure is necessary to protect and defend the rights or property of Central Australia Academic Health Science Network; or
- we consider it necessary to do so in order to enforce or apply the terms of any agreements with you.

### Use of your personal information

For each visitor to reach the site, we expressively collect the following non-personally identifiable information, including but not limited to browser type, version and language, operating system, pages viewed while browsing the Site, page access times and referring website address. This collected information is used solely internally for the purpose of gauging visitor traffic, trends and delivering personalised content to you while you are at this site.

From time to time, we may use customer information for new, unanticipated uses not previously disclosed in our privacy notice. If our information practices change at some time in the future we will use for these new purposes only, data collected from the time of the policy change forward will adhere to our updated practices.
